ORDINANCE 2022-2

AN ORDINANCE PROVIDING FOR THE 2022 LEVY,  
ASSESSMENT AND COLLECTION OF TAXES IN 2023 FOR THE  
FISCAL YEAR BEGINNING  
APRIL 1, 2023 and ENDING MARCH 31, 2024  
FOR THE TOWN OF RIVER FOREST, COUNTY OF COOK,  
STATE OF ILLINOIS

WHEREAS, all legal requirements have been complied with:

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TOWN TRUSTEES OF THE TOWN OF RIVER FOREST, COOK COUNTY, ILLINOIS, in meeting assembled, as follows:

**SECTION 1:** That pursuant to authority vested in them by law, this Board of Town Trustees does hereby find, declare and ordain that the sum of SIX HUNDRED EIGHTY-FIVE THOUSAND, NINE HUNDRED FIFTY-NINE (\$685,959) is the amount required to be raised by general taxation to be collected from the 2022 tax levy for the fiscal year beginning APRIL 1, 2023 and ending MARCH 31, 2024 of the TOWN OF RIVER FOREST, in order to meet and defray part of the necessary expenses and liabilities of the Town appropriated by the Annual Town Budget and Appropriation Ordinance of the TOWN OF RIVER FOREST to be duly passed and adopted by the Board of Town Trustees on June 20th, 2023 (as currently scheduled), and is hereby levied on all property within the TOWN OF RIVER FOREST, subject to taxation for the current fiscal year, as hereinafter provided; the said levy, appropriations and the estimated revenue from sources other than general taxation being itemized for uses and purposes as follows:

**SECTION 2:** That the Town Clerk of the TOWN OF RIVER FOREST is hereby authorized and directed to certify to the County Clerk the amount of taxes required to be raised for all town purposes, and to file a copy of this Annual Town Tax Levy Ordinance, duly certified by the Town Clerk of River Forest, and with the County Clerk of Cook County, Illinois within the time limit prescribed by law.

**SECTION 3:** That if any item or portion of this Ordinance is for any reason held invalid, such division shall not affect the validity of the remaining portion of such item or the remaining portion of this Ordinance.

**SECTION 4:** That this Ordinance shall be in full force and effect from and after its passage and approval, and recording as provided by law.



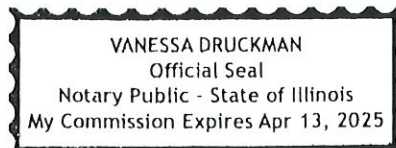


